This privacy policy is intended to provide information on KonceptForm's processing of personal data. This policy applies if you visit our website, you are a contact person or representative of KonceptForm, B2B client or other business partners.

1. Website users

Data controller

Unless otherwise informed, KonceptForm is the data controller in relation to the personal data collected when you visit and make use of the functions on our website.

Collection of personal data

KonceptForm may collect, process and store personal data about you in the following instances:

When you visit and browse our websites

When you sign up to receive KonceptForm's newsletter

When you communicate with KonceptForm

Types of personal data

KonceptForm may collect, process and store the following personal data about you:

Name, e-mail address, telephone number and similar identification data

Company name and company address

IP address

Purposes of the processing

Your personal data may be processed for the following purposes:

Newsletters and other promotional communication

Promotional marketing in general

General communication

Providing support

Product and service development

Statistics and analysis

Legal basis

KonceptForm will process your personal data based on one or more of the following legal bases:

Legitimate interests: In most cases, the processing of your personal data will be based on our legitimate interest in, for instance, conducting statistics, analysis, marketing activities (where consent is not required), providing support as well as improving and developing our products and services (Article 6(1)(f) of the GDPR).

Consent: KonceptForm will only use your personal data in order to send you product information, newsletters and other marketing material via e-mail if you have provided your prior and explicit consent hereto, unless applicable legislation allows us to contact you without such consent (Article 6(1)(a) of the GDPR).

Contractual obligation: The processing of your personal data may in some cases be necessary for the performance of a contract between KonceptForm and you, e.g. when you create a user account or order samples (Article 6(1)(b) of the GDPR).

Retention period

Data controller

Collection of personal data

Legal obligation: The processing of your personal data will in some cases be necessary to comply with legal obligations, such as our obligations to prevent illegal activity (Article 6(1)(c) of the GDPR).

3. Designers and Agents

Data controller

During the course of your cooperation with KonceptForm, we may process your personal data. Unless otherwise informed, the KonceptForm entity you, your company or the company you are employed with conclude an agreement with or correspond with is the data controller in relation to the personal data collected.

Collection of personal data

KonceptForm may collect, process and store personal data about you in the following instances:

When you make use of KonceptForm's websites and portals

When you collaborate and communicate with KonceptForm

Disclosure to other data controllers and transfer to data processors

Your personal data may be disclosed to accountants. Under certain circumstances it may also be necessary to disclose your personal data to lawyers, courts, public authorities, the police and potential buyers.

We do not use cookies on our website.

Security

We have implemented numerous security measures to prevent, for example, the loss and misuse of personal data under our control. Accordingly, endeavour to protect the quality and integrity of your personal data.

Your rights

Your rights have to be met by a data controller, where we are not a data controller we make the best effort to help you with you query.

- You have a right of objection towards our collection and further processing of your personal data
- You have the right to have your personal data rectified and deleted, with certain national statutory exceptions
- You have the right to request us to restrict the processing of your personal dat

- Transferring your personal data which you have provided us with to another data controller (data portability)
